TeleFamilies Study Progress Report

By the time you receive this newsletter, recruitment for the study will be complete. Thank you again for helping us reach this important milestone. As of August 1st, 85% of participating families have been randomly placed into one of the three study groups. All three groups are equally important. The random group assignment occurs six months after starting the study. A **survey packet is sent by mail** at this time. The survey packet gives us a broad picture of your child and helps us measure different ways of coordinating your child's care. We appreciate the time it takes to fill out and return the survey packet. If you need help finishing your survey packet, please call Cathy or Rhonda at 612-625-9431.

Over the past six months, **TeleFamilies team members presented our work** on this new approach to coordinating care at local,

national and international conferences. We have spoken to people from around the world who also have the goal of supporting families of children with complex conditions. We will continue to share the results of the TeleFamilies study so that others can learn from the results and we can learn from their experiences and questions.

In June, we said good-bye to Dr. James McCord, who moved to Portland, Oregon. Dr. McCord's dedication and leadership made the TeleFamilies study possible at Children's. The Parent Educational Advocacy Training Center (PEATC) recently announced Version 2 of the IEP Checklist iPhone app. The IEP is an Individualized Education Program designed to support the educational

needs of students with disabilities. The IEP Checklist app helps parents of students with special needs become better-informed advocates by making IEP information easier to access. Version 2 has

active links to the relevant language in the federal regulations; allows users to record the IEP meeting or record notes; and has the capacity to print out notes and click on a checklist as requested items are discussed.



